### **Agreement between User and [gulfcoastsafestreetssummit.org](http://gulfcoastsafestreetssummit.org)**

Welcome to [gulfcoastsafestreetssummit.org](http://gulfcoastsafestreetssummit.org). The Summit is a collaborative effort between the Florida Department of Transportation and six metropolitan planning organizations; Forward Pinellas, Hernando/Citrus MPO, Hillsborough MPO, Pasco MPO, Polk TPO, and the Sarasota/Manatee MPO.

The Summit is an educational event that brings together national speakers, public officials, technical staff, sister counties, and community partners to elevate our efforts on how to design and implement safe and equitable transportation facilities for all modes of transportation.

Conference registration canceled online on or before November 1, 2020 is refundable but subject to a \$10 administrative fee.

Registrants canceling on or after November 2, 2020 will not receive a refund. The refund and cancellation policy will not be waived. Registration fees may be transferred to another individual; the invoice for the new registration will be revised to reflect the new registrant's membership status.

In the event GCSSS must cancel the Summit due to unforeseen circumstances, GCSSS will refund the cost of registration. However, GCSSS does not assume responsibility for any additional costs, charges, or expenses; to include, charges made for technology, travel and lodging.

**Class Action Waiver**

Any arbitration under these Terms and Conditions will take place on an individual basis; class arbitrations and class/representative/collective actions are not permitted. THE PARTIES AGREE THAT A PARTY MAY BRING CLAIMS AGAINST THE OTHER ONLY IN EACH'S INDIVIDUAL CAPACITY, AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PUTATIVE CLASS, COLLECTIVE AND/ OR REPRESENTATIVE PROCEEDING, SUCH AS IN THE FORM OF A PRIVATE ATTORNEY GENERAL ACTION AGAINST THE OTHER.
